

Privacy Statement for [www,forestsales.ie](http://www.forestsales.ie)

1 Purpose

The purpose of personal data collection on www.forestsales.ie is to verify the identity of registered users who will have access to all the details of the forests and properties on sale on forestsale.ie. It also provides a crosscheck for forest owners and landowners to verify with persons who may view their forests and lands. Personal data may also be used to contact registered users by phone, text, email and post to further inform them of properties, forest and land being offered for sale and to advise of other services being offered by www.forestsales.ie. Personal data may also be used to survey the registered users about their requirements and general forestry topics.

Forestsales.ie reserves the right to alter, edit, delete, erase personal data that is entered on registration to keep it up to date or correct errors or to delete spurious or double entries, and reserves the right to deny or deactivate registration and access to anyone without prejudice.

2 Disclosure

Personal data provided by registered users will not be released to third parties without the consent of the registered user. (Unless required by law). However the number of registered users and their general geographical location may be released to third parties who may wish to advertise on www.forestsales.ie now or in the future together with number of hits on the website and frequency of hits and other analytical data.

3 Right of Access

All registered users have the right to receive a copy of their personal data. If a registered user wishes to receive a copy of their personal data they should make the request in writing which can be sent by post or email and should be sent to the person identified in Section 1. of this Privacy Statement. Any such request will be complied with within 40 days of receipt. There is no fee for the first request by a registered user but for subsequent requests there is a fee of €6.35 payable to James Cleary & Sons or ForestSales.ie Main street Castlereagh Co Roscommon.

4 Right of Rectification or Erasure

Any registered user has the right to have their personal data corrected if inaccurate and erased if requested. Such a request should be made in writing which can be sent by post or email and should be sent to the person identified in Section 1. of this Privacy Statement. Any such request will be complied with within 40 days of receipt. There is no fee for this request.

5 Extent of Data Being Processed

All personal Data provided may be processed in accordance with Section 1 Purpose above.

6 Cookies

The website www.forestsales.ie only uses cookies for login the login session. No other data is collected.

7 Security

All personal data is stored securely and all passwords are encrypted and are not accessible by the website administrators. The website is hosted securely by letshost.ie.
